Any persons wishing to erect a headstone must first submit the design to the Clerk of Langtoft Parish Council. The Parish Council reserves the right to reject any design it considers unsuitable. The Parish Council can refuse an inscription if it believes it to be unsuitable or offensive.

The placing of any memorials without the correct authority may result in the Parish Council asking for them to be removed.

Langtoft Parish Council does not accept responsibility for any damage to grave or memorial stones or flower receptacles.

Burials shall subsist for a period of 100 years from the date of the grant, unless extended by the Burial Authority,

Charges are subject to an annual review, it is the responsibility of the purchaser to ensure that they check current charges.

The Parish Council does not undertake the digging of plots, responsibility for this rests with the undertaker. Grave diggers must adhere to the Code of Practice for Grave Digging and safe working procedures.

All burial plots are single depth plots only.

No trees/shrubs or plants are to be planted upon the grave area or within the cemetery.

Graves must be positioned as in the Burial ground layout drawing and regulations.

Graves must be filled in accordance with the current burial regulations.
