# 17/02033/PLF - Erection of detached dwelling

Land South of 4 West View Back Lane Langtoft East Yorkshire YO25 3TB Applicant: Mr C Buckborough Application type: Full Planning Permission

The parish council does not believe this planning application should be approved until guarantee has been given that the surface water is directed into an on-site soakaway, to prevent excess water flowing onto the highway. Also with the proposed house being a five bedroom property, it is more than likely there will be two or more vehicles connected to the property, with this in mind has consideration been given to where the vehicles would safely park without causing an obstruction on the narrow highway.
